NECESSARY QUALIFICATIONS:

- High School Diploma or Equivalent
- Ability to read and record data
- Ability to understand and comply with written and verbal operating procedures and instructions
- Computer skills

NATURE OF WORK:

- Under the direction of the Shift Supervisor and 1st Plant Operator, this position assists in the operation of the Waste-to-Energy Facility.
- Assists, and participates in, the operation and repair of the facility.
- Operate the refuse canes to charge the furnaces at the prescribed rate.

EXAMPLES OF WORK:

- Mix solid waste using crane to achieve proper mix of fuel
- Remove all unacceptable waste from the pit and place in reject container
- Safely charge the furnaces with refuse crane
- Assists in the general operations of the Plant as directed by supervisors
- Assists employees engaged in operating, servicing, and maintaining the boilers and auxiliary equipment
- Produces records and information used to generate reports on daily, weekly, and monthly operations
- Performs all housekeeping duties in Control Room.
- Performs housekeeping duties in Plant as direct by Supervisors.
- Operate control system as necessary for relief of 1st Plant Operator & Shift Supervisor.
- Performs other related works as required

KNOWLEDGE, SKILLS, AND ABILITIES REQUIRED:

- Some knowledge of the principles and practices involved in the operation and maintenance of high-pressure steam and electric power generation and related equipment.
- Some knowledge of the principles and practices applied to the operation of a reuse fire furnace.
- The ability to read, understand, and develop facility operating and training procedures
- Ability to prepare and maintain logs of plant operation and production.
- Ability to communicate effectively, both verbally and in writing and in highly stressful situations
- Ability to act quickly and calmly in complex emergency situations
- Considerable experience using computer-based equipment control and data handling equipment.

PHYSICAL REQUIREMENTS:

- Must be able to lift 50 pounds
- Must be able to climb ladders and steps
- Must be able to withstand extreme temperatures
- Must be able to wear a respirator
- Must be able to work in confined space areas
